Unfurnished Single Room: NTD4,000 per month excluding utilities. 2). Furnished Single VIP Suite: NTD700 per day excluding utilities.</p>
<p>Living Costs</p>	<p>Depending on each student's lifestyle. The average monthly costs of living in Kaohsiung are about NTD12,000, including housing cost.</p>
<p>Visa</p>	<p>College of Management, National University of Kaohsiung will apply for the Certificate of Eligibility for a Status of Residence on behalf of the exchange students.</p>
<p>Insurances</p>	<p>It's mandatory for all international students to have health insurance. According to "The National Health Insurance Act," international students can start to enroll in the National Health Insurance six months after the day they obtain legal residency. As a result, international students are required to enroll in transitional health insurance for the first 6 months.</p> <p>Transitional health insurance: NTD3000/6months. National Health Insurance: NTD4,494/semester.</p> <p>Students are also required to have accident insurance when Studying in Taiwan.</p> <p>Student's Accident Insurance: NTD500/per semester.</p>
